LETTER FROM THE FOUNDERS

Dear Friends of CIVIC,

We are winning the fight to abolish immigration detention in the United States! In California--a state that detains a quarter of all immigrants each year--CIVIC drafted and helped pass the first law in the country to outlaw immigration detention expansion for 10 years!

Still, there is much work to do. The Trump administration has taken many steps to expand the imprisonment of mothers, fathers, children, and our friends in immigration detention. Federal data shows that 61% of immigrants given Notices to Appear in court under Trump have been detained, compared to 27% under Obama. Once they are detained, the Trump administration rarely releases asylum seekers on parole and has ended the policy of ICE bonds. What this means is that not only are more people being detained, but once they are detained, less people are being released.

In detention, we have documented widespread sexual assaults, often committed by federal officers, contracted facility guards, and even medical professionals. We also have documented how substandard medical care is contributing to the death of people in immigration detention. In fact, more people have died in immigration detention this year so far than in the same time period under the Obama administration. Other abuses include physical assaults, unlawful strip searches, forced labor, religious freedom violations, and unfortunately so much more. And we are all paying for this!

Only when we educate the hearts and minds of Americans about the brutality of this industry that profits from the imprisonment of children, their parents, and our community members will we be able to put an end to this immoral system. Five years ago, we founded CIVIC to do just that through building and expanding community visitation programs, conducting independent investigations, filing federal civil rights complaints, and lifting up the voices of people impacted by detention.

Due to the generosity of our committed partners and volunteers, this year has been a huge success despite an unfortunate political climate for immigrants. In this coming year, and with the help of our supporters, we will build a country that craves dignity not detention.

Thank you for partnering with us in our mission to abolish U.S. immigration detention, while ending the isolation of people currently suffering in this profit-driven system.

OUR GOAL

CIVIC's goal is to abolish U.S. immigration detention, while ending the isolation of people currently suffering in this profit-driven system.



- We visit and monitor 43 of the largest immigration detention facilities, and we are working to start new visitation programs at 22 facilities!
- We run the largest national immigration detention hotline, receiving over 14,000 calls from people in immigration detention per month.
- Through these windows into the system, we gather data and stories to combat injustice at the individual level and push wide-scale systemic change.

We filed federal civil rights complaints, highlighting abuse in immigration detention.





In May 2017, CIVIC released a joint 103-page report with Human Rights Watch, documenting substandard medical care that contributed to the death of people in immigration detention.





In May 2017, CIVIC sent a letter to DHS on behalf of 115 organizations, 23 legal representatives, and 69 faith leaders and other advocates documenting 805 cases at 37 immigration detention facilities of individuals who have been arbitrarily denied parole or bond since January 20, 2017. CIVIC is working with various civil liberties organizations around the country to consider legal challenges on this issue.





In March 2017, CIVIC documented access denials and restrictions in violation of federal policy at 14 facilities in 7 states. CIVIC won a written commitment from ICE for continued visitation access. Within 24 hours of the filing of CIVIC's complaint, acting ICE Director Thomas Homan responded, indicating that "ICE appreciates the work of CIVIC and other community-based visitation programs" and that ICE has a "strong desire to continue to facilitate" CIVIC's access to immigration detention facilities.



Our early 2016 civil rights complaint at Hudson County Correctional Facility resulted in a county resolution to create the first medical oversight committee in the immigration detention system comprised of advocates.



In April 2017, CIVIC documented over 33,000 complaints of sexual assault against DHS component agencies in the last 6 years. Shockingly, the government only investigated less than 1 percent of these complaints. CIVIC is working with Congressman Grijalva of Arizona and other representatives to push for a policy change that will hold ICE accountable.



Our late 2015 civil rights complaint at Theo Lacy Facility contributed to a federal investigation in 2016 that improved food quality and eliminated an unlawful form of de facto solitary confinement.





CIVIC launched IMM Print, the first blog to feature the voices and artwork of people in immigration detention.

CIVIC's Soros Justice Fellow Tina Shull analyzed media coverage of immigration detention over the last 8 years, finding that immigration detention is three times more visible today than in 2009. However, the complex realities of the detention system remain hidden from public view and there remains a dearth of first-hand migrant accounts.

California Aims to Quash Immigration Ban on Immigration Detention Centers Sneaks into California Detention Growth "Christina Fialho, co-founder and co-executive director of Community" Initiatives for Visiting Immigrants in Confinement (CIVIC), which helped draft the measure, said the provision is going to add much needed oversight to conditions inside detention centers while stunting their growth.

CIVIC drafted and helped pass the first law in the country to outlaw immigration detention expansion!

California's budget bill, AB 103, gave the Attorney General of California the power to monitor all California immigration detention facilities—both private and public. California also appropriated \$1 million dollars per year for the next 10 years for the Attorney General to oversee immigration detention facility conditions.

In addition, the state of California implemented a moratorium on all new contracts between California municipalities and the federal government for immigration detention facilities. This includes contracts for both adult and child detention facilities. About a quarter of people in immigration detention per year are detained in California.

CIVIC continues to fight for the Dignity Not Detention Act, which passed the CA Senate!

CIVIC shut down the Santa Ana City Jail and helped the City become the first sanctuary city in Orange County

At the time of the termination, there were 94 people in immigration detention at the Santa Ana City Jail, including 35 transgender women. We worked with our partners to conduct intakes and provide direct legal support to all of the trans women plus 17 cisgender immigrants. We helped ensure the facility was shut down! before the facility was shut down!

OUR PLANS

Over the next year, CIVIC will:

- 1) Build & support immigration detention visitation programs, visiting 20,000 people in detention;
- 2) Monitor facilities & file federal civil rights complaints to seek justice for immigrants;
- 3) Expand access to our National Hotline, connecting people to their families & our support;
- 4) Collaborate with traditional & new media journalists to expand detention coverage;
- 5) Conduct a study on alternatives to detention and jail reuse for the City of Santa Ana (CA);
- 6) Work with the CA Attorney General to implement AB 103's monitoring provisions; and
- 7) Work with state and federal legislators to continue to curb immigration detention expansion.
